Please read this information guide carefully to be able to safely install, use and maintain your product.

Failure to follow these instructions may cause injury and/or damage and may invalidate your guarantee.

When using electrical appliances, basic precautions should always be followed to reduce the risk of fire, electrical shock and injury to persons, including the following:

- If the appliance is damaged, check with the supplier before installation and operation.
- Do not use this appliance if it has been dropped.
- Do not use outdoors.
- Do not use in the immediate surroundings of a bath, shower or swimming pool.
- Do not locate the appliance immediately below a fixed socket outlet or connection box.
- Do not use this appliance in series with a thermal control, a program controller, a timer or any other device that switches on the heat automatically, since a fire risk exists when the heater is accidentally covered or displaced.
- Use this appliance on a horizontal and stable surface.

This appliance can be used by children aged from 8 years and above and persons with reduced physical, sensory or mental capabilities or lack of experience and knowledge if they have been given supervision or instruction concerning use of the appliance in a safe way and understand the hazards involved. Children shall not play with the appliance. Cleaning and user maintenance shall not be made by children without supervision.

Children aged from 3 years and less than 8 years shall only switch on/off the appliance provided that it has been placed or installed in its intended normal operating position and they have been given supervision or instruction concerning use of the appliance in a safe way and understand the hazards involved. Children aged from 3 years and less than 8 years shall not plug in, regulate and clean the appliance or perform user maintenance.

Children of less than 3 years should be kept away unless continuously supervised.

CAUTION: Some parts of this product can become very hot and cause burns. Particular attention has to be given where children and vulnerable people are present.

Although this appliance complies with safety standards, we do not recommend its use on deep pile carpets or on long hair type of rugs. Ensure that furniture, curtains or other combustible material are positioned no closer than 1 meter from the appliance.

The appliance must be positioned so that the plug is accessible. In the event of a fault unplug the appliance. Unplug the appliance when not required for long periods.

If the supply cord is damaged it must be replaced by the manufacturer or service agent or a similarly qualified person in order to avoid a hazard. Keep the supply cord away from the front of the appliance.

WARNING: This appliance must be earthed.

WARNING: In order to avoid overheating, do not cover the appliance. Do not place material or garments on the appliance, or obstruct the circulation around the appliance.

The appliance carries a DO NOT COVER warning symbol.

WARNING: Risk of fire - We do not recommend the use of this appliance connected through an extension lead or any external switching device such as a plug in timer or remote control plug in adaptor. All heating appliances draw high current through the mains supply and any weakness in the design, connections or components in these devices can easily result in overheating of the connection points resulting in melting, distortion and even the risk of fire!

WARNING: This appliance is not equipped with a device to control the room temperature. Do not use this appliance in small rooms when they are occupied by persons not capable of leaving the room on their own, unless constant supervision is provided.

WARNING: KEEP BATTERIES OUT OF REACH OF CHILDREN

- 1. Swallowing may lead to serious injury in as little as 2 hours or death, due to chemical burns and potential perforation of the oesophagus.
- 2. If you think batteries might have been swallowed or placed inside any part of the body seek immediate medical attention
- 3. Examine devices and make sure the battery compartment is correctly secured, e.g. that the screw or other mechanical fastener is tightened. Do not use if the compartment is not secure.
- 4. Dispose of used button batteries immediately and safely. Flat batteries can still be dangerous.

∆ WARNING

KEEP OUT OF REACH OF CHILDREN Swallowing can lead to chemical burns, perforation of soft tissue, and death. Severe burns can occur within 2 hours of ingestion. Seek medical attention immediately.



CAUTION: No obvious symptoms

Unfortunately, it is not obvious when a button or coin battery is stuck in a child's oesophagus (food pipe). There are no specific symptoms associated with this. The child might:

- cough, gag or drool a lot;
- appear to have a stomach upset or a virus;
- be sick;
- point to their throat or stomach;
- have a pain in their abdomen, chest or throat;
- be tired or lethargic;
- be quieter or more clingy than usual or otherwise "not themselves";
- lose their appetite or have a reduced appetite; and
- does not want to eat solid food/be unable to eat solid food.

These sorts of symptoms vary or fluctuate, with the pain increasing and then subsiding.

A specific symptom to button and coin battery ingestion is vomiting fresh (bright red) blood. If the child does this seek immediate medical help.

The lack of clear symptoms is why it is important to be vigilant with "flat" or spare button or coin batteries in the home and the products that contain them.

GENERAL INFORMATION

Unpack the appliance carefully and retain the packaging for possible future use, in the event of moving or returning the fire to your supplier.

The appliance is a flame effect only. The appliance is designed to be built into a surround or built into a wall.

Please note: Used in an environment where background noise is very low, it may be possible to hear a sound which is related to the operation of the flame effect. This is normal and should not be a cause for concern.

This product contains and utilises water as an aspect of its operation, the adherence to the cleaning requirement as detailed within the instructions is necessary to ensure that risk/s through bacterial proliferation are minimised. Please refer to the Maintenance section in the following instruction booklet for details on the cleaning.

Once installed, never move this appliance or lay on its back, without draining the water from sump and water tank.

WATER QUALITY & CLEANING

Normal clean tap water should be used in this device. In areas with hard water, a water softener (decalcifier) is recommended and more frequent cleaning and maintenance may be required. It is additionally recommended that if this unit is connected to a water supply, that it becomes included within any Legionella assessment.

The product is provided with an in-line mesh filter to help remove contaminants and extend the life of the product.

Unfiltered water supplied from a well or another unmonitored supply is not recommended. The water tank, sump, sump lid, tank cap and air filters must be cleaned once every week, particularly in hard water areas. This is to remove dirt and prevent build up of limescale which could damage the product.

If you intend not using the appliance for longer than a week, drain the water from sump and water tank and dry the sump.

Ensure any soap/cleaning detergents if used are rinsed off fully to remove any residue before reusing parts. Do not use any harsh or corrosive chemicals for cleaning as these could damage the parts.

The sump and the water tank in this product are treated with a biocidal product, Silver Biocide. This conforms to the latest relevant ISO standard.

Do not drink the water from the sump or from the water tank(s).

INSTALLATION INSTRUCTIONS

This section describes how to install and set up your fire. Before you start:

- Ensure that all packing items are removed (read any warning labels carefully) and retain all packing for possible future use.
- Before connecting the appliance, check that the supply voltage is the same as that stated on the appliance.

CONNECTIONS REQUIRED IN ADVANCE OF INSTALLATION

ELECTRICAL CONNECTION

Please ensure a 230/240V 16A power socket is located within 1m of the product. The electrical connection should be accessible during product installation so that the connection can be made to the product easily.

WATER CONNECTION

Please ensure a water connection is located within 1m of the product. The water connection should be one of the following:

A male ³/₄ inch BSP connection (same as a standard supply for a washing machine)

A male $\frac{1}{2}$ inch BSP connection (Fig 32)

Both the water and electrical connections should be accessible during product installation so that the connections can be made to the product easily.

BUILDING THE PRODUCT SURROUND/ENCLOSURE

This product can be built into a wall, surround or structure. Please take note of the product dimensions (Fig.1) and build your wall, surround or structure accordingly. Suitable clearance should be provided to allow the product to be installed easily.

You are required to leave a minimum of 400mm from the base of the fuel bed to any shelf/enclosure above the product (Fig. 2). This will allow enough space above the product to allow the flame effect to form fully and not to be obstructed. When determining a location for the product, ensure that the unit will not be susceptible to drafts, vents, ceiling fans and other air currents. Similar to a candle, large movements of air will affect the unit's ability to create and maintain the flame effect. If the desired location is susceptible to significant air movement, i.e. air vents, the different installation options illustrated in Fig 2 can be used.

VENTILATION

This product needs free ventilation from underneath to operate correctly. There are slots on the underside of the product to allow this free air through the product. The free ventilation helps keep the electronic components cool and allows the mist to rise and leave the product. Please see Fig 3 & 4 for examples of the required ventilation. Please take note of the requirement for a ventilation opening on the shelf where the product sits, to allow a clear path for the air to get to the product.

CAS500P-RGB Free Ventilation Area: Minimum 210cm² CAS1000P-RGB Free Ventilation Area: Minimum 420cm²

WATER CONNECTION

It is recommended that you consult a qualified plumber to ensure a safe and secure installation.

Two adaptors have been supplied with the product to connect the $\frac{1}{4}$ " blue PVC pipe of the product to mains water (Fig 32.1). Either the white $\frac{1}{2}$ inch or the grey $\frac{3}{4}$ inch adaptor can be used to connect the product to the mains. For reference, the $\frac{3}{4}$ inch adaptor is the same connection used on most washing machine supplies. Once the correct mains water connection has been installed, follow the steps below to connect your product to the water supply.

- 1. With the water supply turned off, connect the correct adaptor to the main water supply. (Fig 32.1)
- 2. Position the water filter (Fig 32.5) in a suitable location. This will need to be accessed for future replacement. The two fixing clips can be used to fix the filter to a solid surface, if required.
- 3. Using a sharp knife or blade, cut two lengths of the blue PVC pipe. One length (Fig 32.2) should be long enough to travel from the adaptor at the main supply to the ball valve (Fig 32.3). The second length (Fig 32.4) should be long enough to travel from the ball valve to the inlet of the filter. When cutting the pipe, ensure that the end of the tubing is cut square to prevent leaking.
- 4. Insert the cut pipe into the fittings, ensuring each one is pushed in fully. About 12mm of the end of the pipe should be inserted into each fitting. When inserting pipe into the filter, take note of the flow direction on the filter and ensure the pipe from the main supply is fitted to the inlet of the filter.
- 5. Following the same steps above, cut a length of pipe (Fig 32.6) from the outlet of the water filter to the ball valve which has been supplied already connected to the product (Fig 32.7).
- 6. Before connecting the pipe to the ball valve on the product, flush out the newly plumbed pipe by opening the valve and allowing water to flow. This is to prevent any debris from the installation from entering the product. Once the piping has been flushed out, connect the pipe into the ball valve on the product.
- 7. Before fully installing the product, inspect all water connections by opening each of the valves in turn and ensuring that no leaks are present.

Water Connection – Additional Information

Water Pressure: the water pressure on the appliance should be between 8Bar (800Kilopascals) and 0.5Bar (50Kilopascals). Where required, use a pressure reducing valve.

If the product is being supplied from a header tank, a head of at least 2 metres must be maintained above the product.

ELECTRICAL CONNECTION

Plug the fire into a 16amp 230/240 Volt outlet. Be sure to have access to the plug after installation to allow for disconnection. Ensure that the supply cable exits at the back of the fire at the right or left hand corner to suit your supply socket location and is not trapped under the fire such that it might cause it to be damaged.

INSTALLING THE PRODUCT INTO SURROUND/ENCLOSURE

Once your enclosure has been built to the required dimensions and the electrical connection has been installed, follow the steps below to install your product.

- 1. Sit the product on the constructed base, ensuring the cable is accessible and not caught under the product.
- 2. Ensure the product is at the correct height to suit the installation and ensure it is adequately level. This can be done by adjusting the adjustable feet with a flat head screwdriver. (Fig 5) The levelness of the product can be verified by checking the on-board spirit level which is located on the metal base towards the back of the fire (Fig 6).
- 3. Once the product is at the correct height and is level, centre the product within the opening. If using the LED log fuel bed (which is wider than the product), this can be done by fitting the fuel bed to the product. The fuel bed will centre itself within the opening and its guides will centre the product underneath (Fig 7).
- 4. With the product in its final position, remove the fuel bed and using suitable screws (not provided) screw the product to the surround using the four fixing holes shown in Fig 8.

COMMISSIONING/INITIAL PRODUCT START-UP

CONNECTING THE RECEIVER/TETHERED REMOTE

With the fuel bed removed, Connect the Bluetooth receiver connector into the into the receiver cable socket at the back of the appliance (Fig 9). It is important to ensure that the jack is pushed fully into the socket. Failure to fully insert the connector will prevent the product from functioning correctly. The receiver has a cable length of 1.4m which will allow you position it anywhere around the product. If you prefer to hide it, the receiver can be placed inside the surround/wall. Please ensure that the receiver is not enclosed in metal, concrete or any other dense material, this will affect the signal from the remote control.

INITIAL PRODUCT START-UP

In some cases, where low water pressure exists or where the product is being fed by the pump accessory, the product may start to fill with water but not complete its first fill within the allowed filling time period. It is recommended that each sump is primed with 600-700ml of water before switching on the product for the first time. If measuring this amount of water is not possible, the water guide in the sump moulding can be used for reference. Fill the sump with water until the top surface of the water is level with the top of the water guide. See Fig. 12B for details on the location of the water guide.

After priming the sump(s) the product can be switched on and it should begin to top off the sump(s) with water. Please note, if no water is entering the sump, there may be an issue with the water supply to the product. This error will be represented by the product flashing two times 30 seconds after first turning on the product. Check all water connections and ensure that there are no leaks present. Also check that the leak prevention valve has not been activated; see 'Changing the Leak Prevention Valve Pad' paragraph below under 'Maintenance'. Reset the product by switching off the main switch and leaving it rest for 20 seconds. Switch the main switch back on again and the product should resume operation.

INSTALLING THE LOG FUEL BED (IF SUPPLIED)

The product is supplied with a 'metal fuel bed' fitted. If you have chosen to operate your product with a log fuel bed, remove this metal fuel bed and retain it for future use (Fig. 12). Follow the steps below to install the log fuel bed.

- 1. Gently lift the LED Log fuel bed out of its packaging. CAUTION: The fuel bed weighs 5kg. Be sure to only lift the fuel bed by the two centre logs (Fig. 13).
- 2. Place the fuel bed on top of the appliance, there are 4 plastic guides under the fuel bed to help locate it (Fig.7). Please note the fuel bed can be placed front to back or back to front on the product.
- 3. Once the fuel bed is in place, remove the small loose log (Fig 14). This small log is secured with magnets and should easily lift off the fuel bed.
- 4. Locate the DC jack under the small log and connect it to the corresponding DC jack located on the product through the hole in the fuel bed (Fig.15).
- 5. Each log fuel bed is supplied with a loose non LED log. For single CAS500P-RGB installations, this can be placed on top of the fuel bed or stored away with the packaging. For CAS1000P-RGB or multiple product installations, the loose log can be placed on the join in the centre between two fuel beds (Fig 16).

MULTIPLE PRODUCT INSTALLATION (DAISY CHAINING)

POWER CONNECTIONS

Both the CAS500P-RGB and CAS1000P-RGB products can be installed side by side to elongate the flame effect. When supplying power to multiple products, ensure the maximum wattage of the combined products does not exceed the rated capacity of the MCB (Minature Circuit Breaker) in the circuit.

The water supply to multiple products should be constructed in a manifold style configuration and sized appropriately for the number of units that are being installed so a consistent water volume and pressure is being supplied to each unit.

MULTIPLE PRODUCT INSTALLATION

Follow steps 1-4 in "Installing the Product into Surround/Enclosure" to fit the first product. It is important that the first product is orientated so that the side of the product with the slots is left free and not connected to first end of the installation (Fig 17).

- 1. When the first product is installed and securely fixed, prepare the second product by unscrewing the joining screws and screwing them into the opposite side of the metalwork (Fig 18). Please note, these screws should not be fully tightened and 5-10mm of thread should be left protruding from the edge of the product.
- 2. Fit the second product beside the first product, ensuring the protruding screws of the second product engage with slots of the first product. (Fig 19)
- 3. Ensure the second product is at the correct height to match the first product and ensure it is adequately level. This can be done by adjusting the adjustable feet with a flat head screwdriver. (Fig 5) The levelness of the product can be verified by checking the on-board level (Fig 6)
- 4. Tighten the screws of the second product so that it joins tightly with the first product.

Additional products can be fitted to the second product by following steps 1-4 above.

MULTIPLE PRODUCT CONTROL

Each product has been supplied with its own link wire in order to form a hardwire link between multiple products. Please follow the instructions below to link multiple products together.

- 1. Identify the 'master' product in the installation. It should the product on the left hand side of the installation.
- Connect the Bluetooth receiver to this product (Fig 20A, 21A). This will be the only Bluetooth receiver in the installation and will control the rest of the products in the installation. In an installation of both CAS500 & CAS1000 products, a CAS500 receiver (Fig 9) should be connected to the 'master' product.
- 3. Plug the daisy chain link wire into the connector on the right hand side of the first/master' module (Fig 20B, 21B).
- 4. Feed the wire through the hole in the metalwork and into the housing of the next product in the installation.
- 5. Plug the daisy chain link wire into the left hand connector on the RGB strip on the following product (Fig 20C, 21C).
- 6. Each product is fitted with a rotary identifier switch which must be adjuted for daisy chaining (Fig 22). The master unit should be set at 0 (default). Subsequent units should be given a unique identifier number on each binary switch.
- 7. Repeat steps 3-6 above in order to connect subsequent products in the installation.

Once set up, any command sent to the first product will be sent to all subsequent products. Flame height control and sound level control of the master product is matched for all subsequent products. If individual flame height control is required, this can be done by using the on board flame height controls on the product (Fig 23).

Additionally, the software of the product has been designed in such a way that when multiple products are connected to a main switch, products can be manually switched off and when switched back on they will operate in the same state as before they were switched off.

OPERATING THE PRODUCT

This section describes how to activate your fire using either the manual controls or remote control.

MAINS SWITCH

The mains switch is located under the fuel bed on the module and controls the electricity to the appliance (Fig 23A). Note: This switch must be in the 'ON' (1) position for each appliance to operate.

MANUAL CONTROLS

Manual controls are located on the cassette module under the fuel bed. There are also manual controls on the tethered receiver unit which is fitted loose.

REMOTE CONTROL

The remote control is supplied with 2x CR2032 batteries already fitted. Pull both tabs from the rear cover to engage the batteries (Fig 24) and allow remote operation.

Note: The tethered receiver must be fitted to the product for remote control operation.

PAIRING THE REMOTE CONTROL

The remote control has wireless Bluetooth technology and needs to be paired to the receiver. This can be done by following the steps below.

- 1. Press the rocker switch to the on (I) position.
- 2. Press the \mathbf{U} button on the Button Panel; the product will turn on.
- 3. Press the **\$** button on the Button Panel, the LED's will start to slowly blink on and off.
- 4. Press the **b** button on the remote control; the product LEDs will flash quickly five times and the product will then automatically switch off. The remote control is now paired to the product and can be used to switch it back on.

TO REPLACE THE BATTERIES

- 1. Remove battery cover of the remote control using a Philips screwdriver (Fig 25).
- 2. Correctly install two 3 Volt (CR2032 or similar) battery in the battery holder with the + side facing up .

3. Secure the battery cover using the previously removed screw.

Batteries must be recycled or disposed of properly.

Check with your Local Authority or Retailer for recycling advice in your area .

Frequency band(s) this product operates in: 2.4GHz

Maximum radio-frequency power transmitter in the frequency band(s) this product operates in: 2.71dBm

GETTING THE DESIRED FLAME EFFECT

- 1. Switch the appliance on by pressing the main switch to the on position and pressing the 🕁 button. The flames will start after 45seconds.
- 2. Press the and buttons to adjust the flame to your desired level. Please give the flame generator time to react to the changes you make.

Once you have made your adjustments to both the flame height and crackling sound, the appliance will keep these settings even if you power off the appliance by either the on/standby button or by the main switch. The next time you switch on the appliance, it will start up as normal, wait 45 seconds for the flames to start and then revert to the adjusted settings.

NOZZLE INSERTS

Nozzle inserts have been supplied and fitted to the nozzle opening. These inserts are used to alter the profile of the flame effect. These inserts can be removed if a different flame profile is preferred. In addition to these inserts, inserts for blocking the flame in certain areas have also been supplied. To fit these inserts, remove the exisitng inserts that have been supplied and fitted to the product. Break the blocking inserts into the required length. Snap the inserts into the nozzle opening in the desired location. See Fig 26 for further details.

FLAME CONNECT APP

The fireplace is capable of being controlled using the Flame Connect App for mobile devices. This is available to download to your device from Google Play or Apple App stores. Follow the on screen instructions for set-up. NOTE: The fireplace will not operate using the provided remote control when the app is open on a mobile device.





MAINTENANCE

GENERAL TIPS

Only use filtered/decalcified water in this appliance.

Always ensure that the appliance is sitting on a level surface.

If you intend not using the appliance for longer than a week, remove and empty the sump and water tank.

Once installed, never move this appliance or lay on its back, without draining the water from sump.

CLEANING

WARNING: Always press Switch 'A' to the 'OFF' (0) position (Fig 23A) and disconnect from the power supply before cleaning the fire.

We recommend cleaning the following components once every week, particularly in hard water areas: Sump, Nozzle, Tank cap and seal, Air filter

For general cleaning use a soft clean duster – never use abrasive cleaners.

To remove any accumulation of dust or fluff, the soft brush attachment of a vacuum cleaner should occasionally be used.

SUMP

- 1. Press Switch 'A' to the 'OFF' (0) position (Fig 23A)
- 2. Gently lift off the fuel bed and place it aside.
- 3. Disconnect the fill cap from its position on top of the sump (Fig 36) or remove water bottle if used (Fig 10 & 11).
- 4. Disconnect the electrical connector to the transducers, located on the right side of the sump. (Fig 27).
- 5. There are two orange clips holding down the nozzle on the sump; one on the left and one on the right hand side of the nozzle. On the left side, press in the clip with one hand and with the other lift the nozzle out of the clip. Repeat this for the right side (Fig 28). The nozzle can now be lifted up and placed aside (Fig 29).
- 6. Gently lift up the sump (Fig 30), taking care to keep it level so as not to spill any water. Sit the sump in the sink.
- 7. Carefully empty the sump into the sink taking note that the transducer is held in place by a retaining clip.
- 8. Put a small amount of washing up liquid into the sump, and using a soft brush, gently clean all surfaces in the sump and gently clean the transducer including the cone and metal discs located in the top grooved surface.
- 9. When cleaned, thoroughly rinse the sump with clean water to remove all traces of washing up liquid.
- $10. \ \mbox{Clean the nozzle with a soft brush and flush out thoroughly with water.}$
- 11. Reverse the above steps 1 6 to reassemble.

TRANSDUCER

The transducer is a consumable item and may need to be replaced through time, depending on its usage. Replacement transducers can be purchased from our your dealer. The transducer is fixed in the sump with a plastic clip. If you need to replace your transducer:

- 1. Follow the steps 1-5 in the CLEANING Sump section under 'Maintenance' to gain access to the transducer.
- 2. Press the clip back and lift the transducer upwards out of its holder.
- 3. Place the new transducer into the sump, ensuring the its cable does not sit over the cone.
- 4. Reverse the above steps to reassemble the nozzle and sump.

AIR FILTER

- 1. Gently lift out the fuel bed and place it aside.
- 2. Gently slide the air filter upwards out of its plastic holder. (Fig 31)
- 3. Gently rinse with water in the sink and dry with fabric towel.
- 4. Replace the filter making sure that the coarse black filter is facing outwards.
- 5. Replace the fuel bed.

CHANGING THE LEAK PREVENTION VALVE PAD

A leak prevention valve has been fitted to the appliance as an additional safety measure (Fig 33). In the unlikely event that a leak occurs inside the product, the valve will prevent water from flowing to the product. When the valve has been activated, the pad within the valve absorbs water and expands, shutting off the valve. It can be verified that the valve has been activated if the pad has expanded and the arm of the valve is in its upper positon (Fig 34). If the valve has been activated, the pad must be replaced. A spare pad has been supplied with the product, please follow the steps below to change the pad.

- 1. In order to gain access to the valve, the nozzle and the sump must be removed first. Follow steps 1-6 above under "Sump" to remove the sump and nozzle.
- 2. Verify that the valve has been activated by checking the orientation of the valve arm. If the pad has expanded and the valve arm is in the upper position (Fig 36), the valve has been activated.
- 3. Remove the old expanded pad and dry the area around the valve. Replace the pad with a new pad, while ensuring the new pad does not come into contact with water.
- 4. Close the arm of the valve on top of the newly fitted valve (Fig 35).
- 5. Replace the sump and nozzle and check that the product is operating by switching it on and ensuring water is

flowing into the sump. The product should be carefully inspected for leaks after replacing the valve.

Please note the product is not to be operated without the pad being fitted to the leak prevention valve. If leaking persists after replacing the valve, contact your dealer or service agent.
